On Good Friday, 11 students travelled from Austin to Sweetwater to take a tour of the Sweetwater Wind Farm. Ken Becker, Executive Director of Sweetwater Enterprise for Economic Development, Inc. (SEED), met with the students and their professor to assist them with the tour.

The attending students were all Masters of Law (L.L.M.) students at the Kay Bailey Hutchinson Center for Energy, Law, and Business, an interdisciplinary academic center created by the School of Law and the McCombs School of Business at the University of Texas at Austin. The mission of the KBH Energy Center is to provide the finest educational opportunities in the United States to students who wish to pursue careers in energy. Each of the 11 students obtained a law degree prior to enrolling in the Wind Law program at UT.

Some of the students travelled from as far as China and Africa to study Wind Law in Texas because Texas is the model for wind energy that is most often used by other states and countries. There are only two schools in the United States that offer courses on Wind Law, and both of them are in Texas: Texas Tech University and the University of Texas. Because Texas is the model for wind energy, the students can take what they learn here and apply it to wind energy businesses in their home countries.

Rod Wetsel, a native of Sweetwater, is the professor for the Wind Law Seminar Course at UT that these students are currently enrolled in. He has been a practicing lawyer in Sweetwater since 1978. When the commercial wind industry came to Sweetwater nearly 20 years ago, Wetsel represented landowners on wind leases and wrote some initial articles on preparation of those leases. In 2011, he co-authored a book entitled Texas Wind Law (now titled Wind Law) published by LexisNexis publishing company for use in law school instruction. In 2012, Wetsel became an adjunct professor at UT Law School and has taught there every year since on a part-time basis. He makes the lengthy commute to Austin one day a week to teach a writing seminar in wind energy. In the fall, he co-teaches a wind energy class with Ernest Smith, a foremost authority on energy law and who has been teaching at the law school for 52 years. Both of the classes cover all aspects of wind

Policy update approved by school board

Several policies were discussed at the Sweetwater ISD (Independent School District) Board of Trustees' meeting held on Monday evening.

Policy Update 104 was approved, which affected several local policies. Among the issues changed were instructional arrangements for homebound instruction; equal educational opportunity; admissions; attendance, notably attendance accounting; and student welfare in regard to freedom from discrimination, harassment and

energy law with Texas as the model state. This semester, Wetsel has 20 students in the class, and he is assisting three other students (one of which is an L.L.M. student) with directed research papers.

"As a source of renewable energy, wind is a comparably new field and is growing rapidly," stated Wetsel. "Many of my students are interested in exploring opportunities in this area either to work solely or in conjunction with oil and gas."

Maria Bianchi, a Wind Law student from Argentina, was one of Professor Wetsel's students that visited Sweetwater on March 25. This was Bianchi's first time to see a wind farm. She mentioned that Argentina has

just recently started developing wind farms. "The energy field is very important because energy is something we all need," said Bianchi on why she is studying Wind Law. She plans on going back to Argentina after she completes her schooling and working in the wind energy field there.

The students toured the operations building and a wind turbine at the Sweetwater Wind Farm. They also got to witness how the Supervisory Control And Data Acquisition (SCADA) computer system remotely monitors and controls the wind turbines. They then enjoyed a lunch catered by Big Boy's BBQ before returning to Austin

retaliation

Notable changes within the policy included the effects of the passage of the constitutional amendment that increased the homestead exemption from \$15,000 to \$25,000, the protocol of posting financial reports to the district website or linked to the state comptroller's website, the implementation of recording devices in special education classrooms beginning next school year, the rights and opportunities for students that are homeless or in foster care, and the wellness policy that is still being developed in the district, among others.

The meeting also included the approval of the instructional materials allotment and TEKS certification for the 2016-2017 school year, which would approve any textbooks or materials that might be adopted. While none are up for adoption this year, materials for any new

classes would also fall into the category.

In addition, the consent agenda was approved, which included the minutes for the Feb. 10 special team training meeting, the Feb. 18 regular meeting, the financial statement for February 2016, the investment statement, and the delinquent tax lot bids that met the minimum bid requirement. There were two delinquent tax lot bids, however, that did not meet the minimum and were not accepted by the board.

And as part of the Superintendent's report, tax collections were reported at \$7,725,876, or 93%, for the M&O (maintenance and operations) and \$850,792, or 93%, for the I&S (interest and sinking). Enrollment numbers saw an increase, with 25 students added from last month for a total of 2,181 students as of March 1.
